Northern Cambria School District Hybrid Schedule **Yellow Phase**

Students will be split into group A or B based on household address, class criteria, and last name K-12. The students group assignments have been sent to your child's school email address.

The school year start date has been changed to Tuesday, September 8th.

Group A students will attend in person Monday and Tuesday.
 Group B students will attend synchronously via Google Meet on Monday and Tuesday.

All students will attend synchronous instruction via Google Meet on Wednesday.

Group A students will attend synchronously via Google Meet Thursday and Friday.
 Group B students will attend in person Thursday and Friday.

Students retain the option to elect to attend synchronous instruction all five days.

In the synchronous learning scenario the student will be able and required to watch instruction conducted live in the classroom at home and complete assignments through Google classroom.

All synchronous virtual learners will be on the same learning path as students in the building. Synchronous learners will be instructed by Northern Cambria School District teachers which will enable a seamless transition when the student moves back into the building.

The primary recommended mode of instructional delivery will be live synchronous instruction during the regular school day using Google meet video conferencing and Google classroom. Recorded instruction will also be posted the day following the students regular school day using Google Classroom. The Northern Cambria School District highly recommends students attend the lessons live. Assignments must be completed by the due date and assessments must be completed live. In the event that an assessment cannot be completed live an alternate assessment may be given.

All teachers will be available live for office hours each day to enhance school/home communication during the week.

Grading will not be pass/fail. The traditional percentage grading scale will be used in the synchronous learning platform and all students will be responsible for all material presented on synchronous instructional days.

Academic eligibility for participation in sports/activities will be run weekly. Any student who is missing assignments in two or more courses will be ineligible for sports/activities until the assignments are completed. Percentage grades will also be run every Friday as they have been in the past. Any student not passing a minimum of four credits will be ineligible from Sunday to Saturday.

Attendance will be mandatory and violators subject to applicable school policies and regulations.

Breakfast and lunch will be available to online students via curbside pickup at the middle school. Students in the building will eat their normal lunch and grab and go breakfast will be available as students enter the building in the morning. Details will be forthcoming.

The district will provide chromebooks to all students K-12 for synchronous instruction. Chromebooks will travel with the student between home and school. For those without internet service, Comcast offers a starter program called Comcast Internet Essentials. This program provides families and other low-income households with in-home Internet to stay connected. Current Xfinity Internet customers are not eligible for Internet Essentials. Pennsylvania's mask order requires all students and staff to wear a mask when in the building. The District will provide each student in K-4 a face shield and mask. Students in grades 5 to 12 will be provided two washable cloth masks. Schools may allow students to remove face coverings when students are:

- Eating or drinking when spaced at least 6 feet apart; or

- When wearing a face covering creates an unsafe condition in which to operate equipment or execute a task; or
- At least 6 feet apart during “face-covering breaks” to last no longer than 10 minutes.

Medical excuses must contain a diagnosis for students to be exempt from the mask requirement. Medical excuses should be turned into the school nurse.
